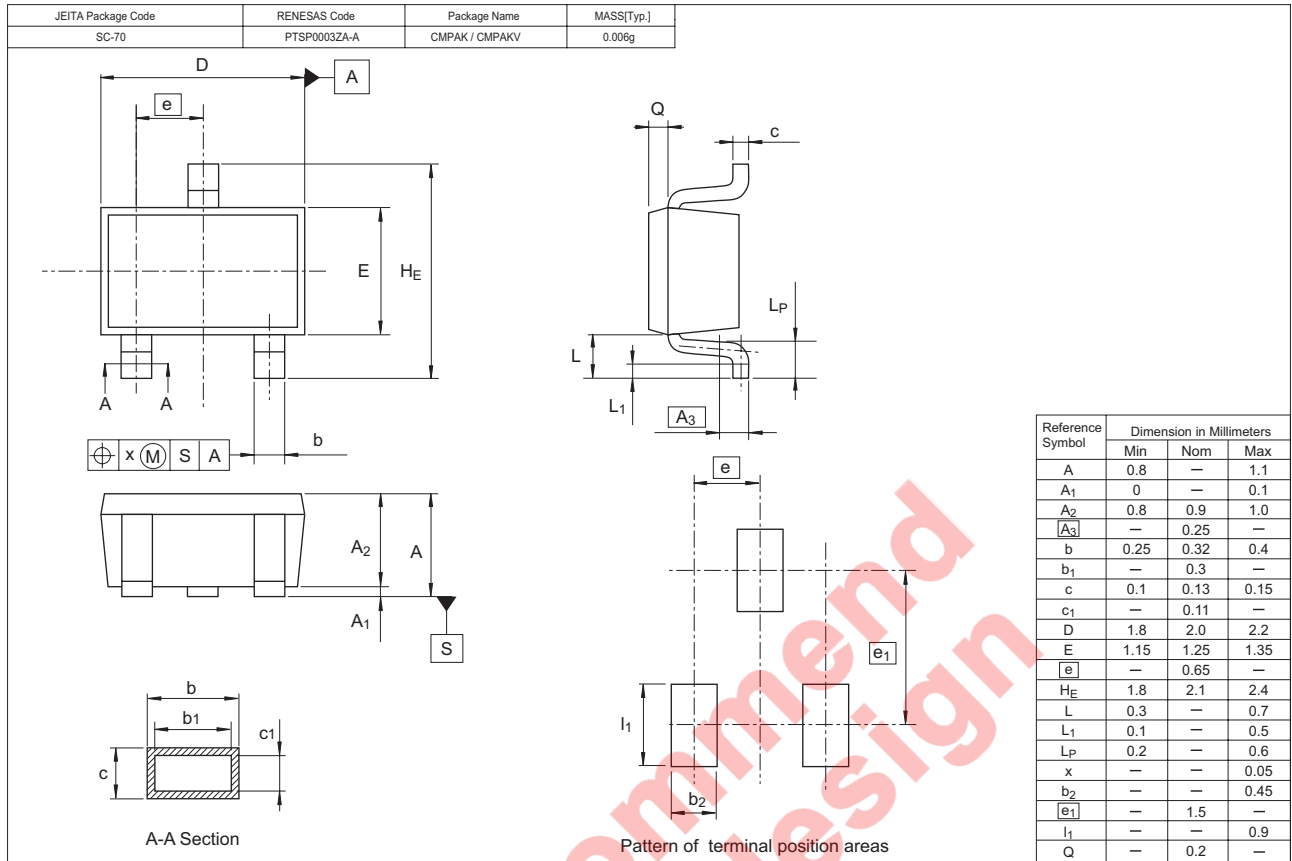
Main Characteristics
