Main Characteristics



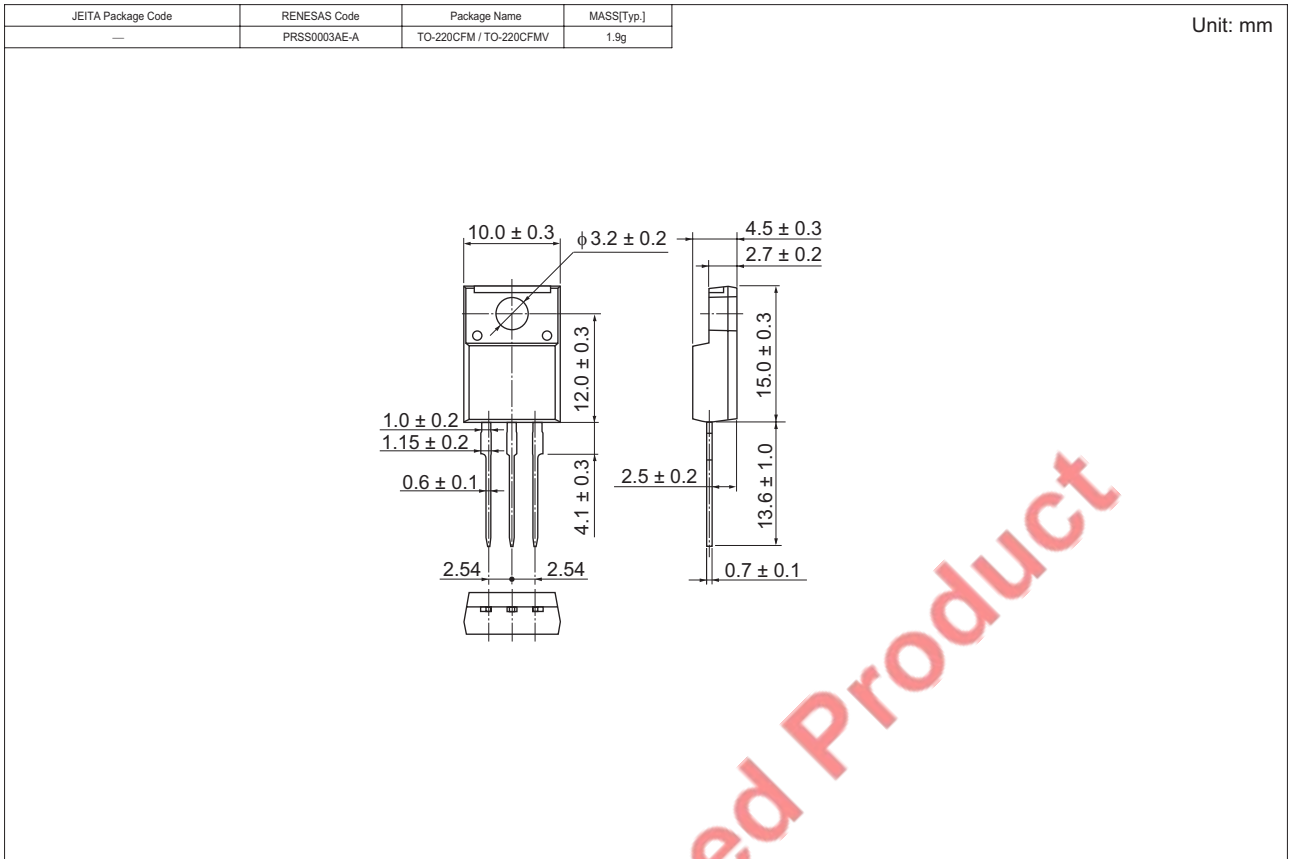
