Main Characteristics



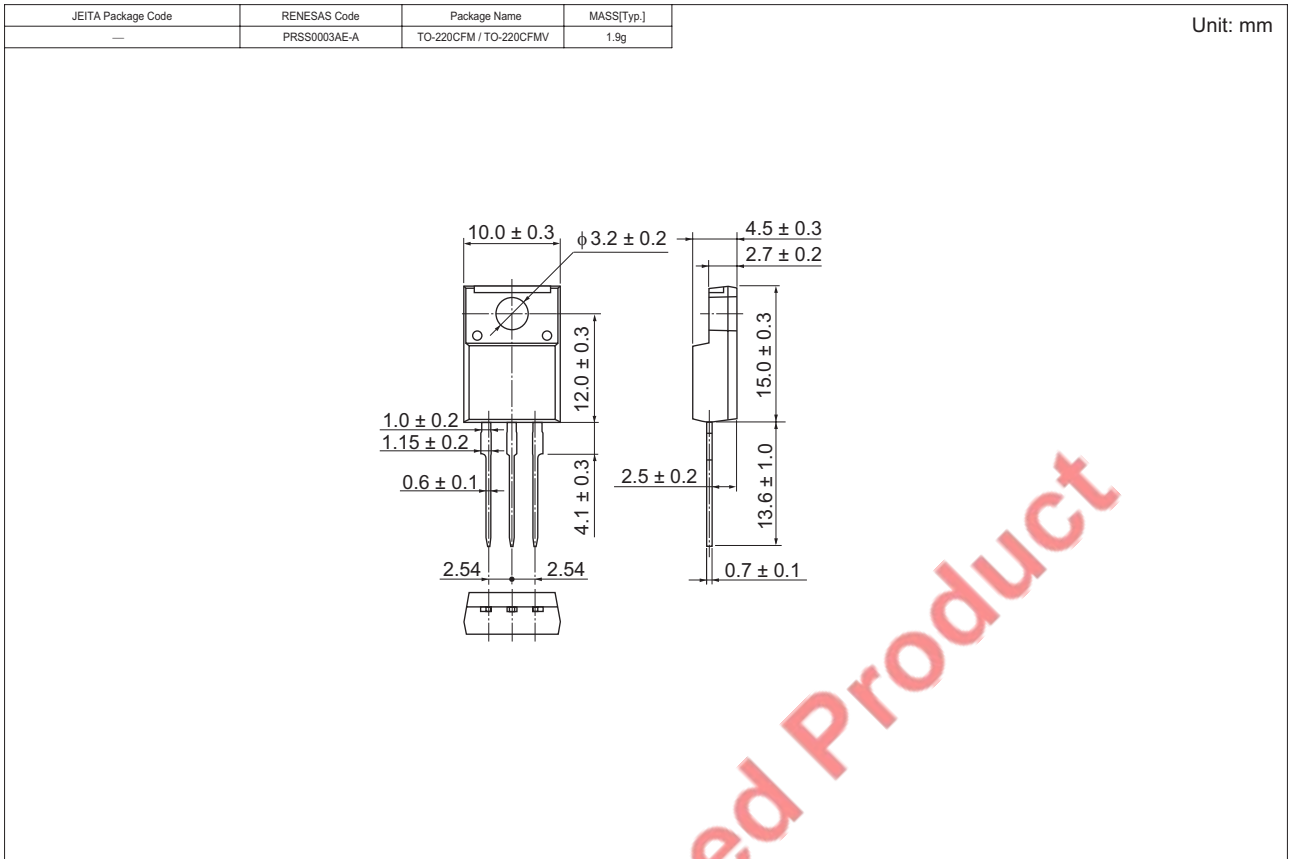
