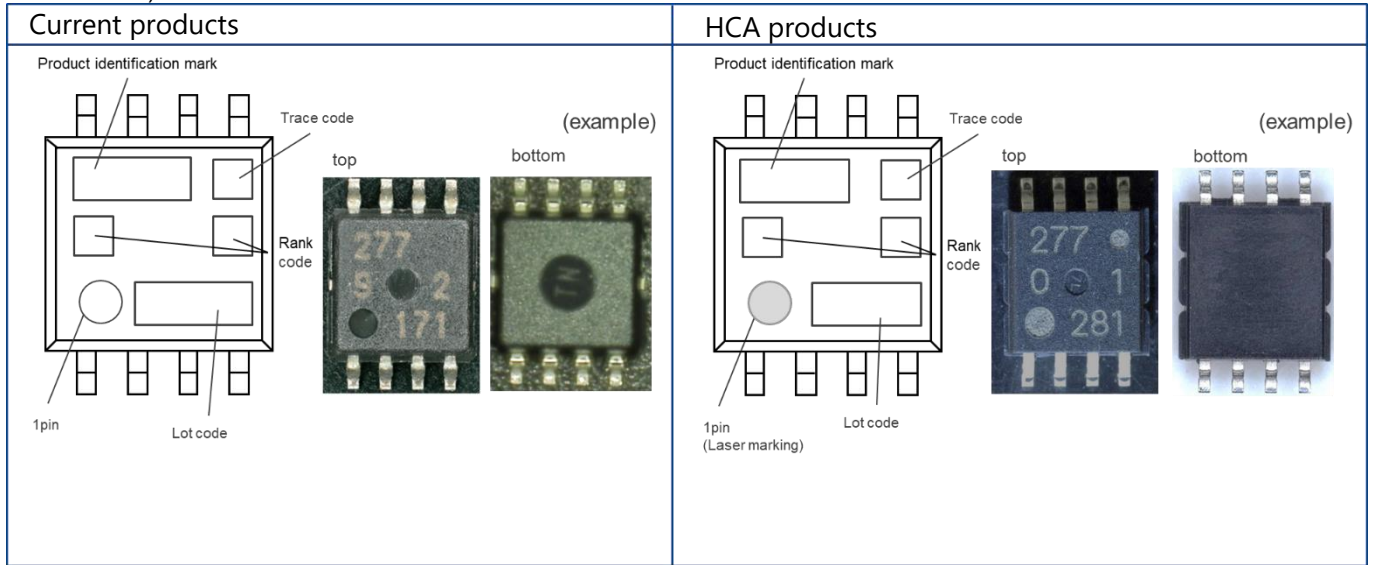

**Product Identification:**

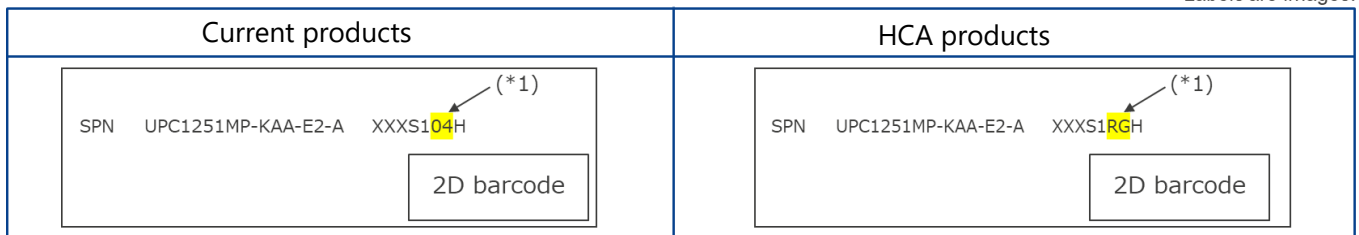

Production sites can be identified by labels (reels, packaging boxes).

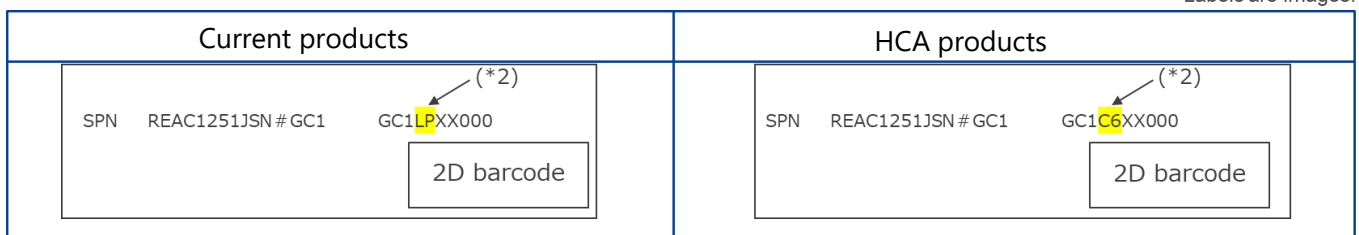
Examples of products beginning with UPC
