- Dimension b applies to metallized terminal and is measured between 0.15 and 0.30 mm from the terminal tip. If the terminal has the optional radius on the other end of the terminal, the dimension b should not be measured in that radius area.
- ND and NE refer to the number of terminals on each D and E side respectively.
