## **Test Circuit 1 Avalanche Capability**






## Test Circuit 2 Switching Time








### FORWARD BIAS SAFE OPERATING AREA




DRAIN CURRENT vs. GATE TO SOURCE VOLTAGE




TOTAL POWER DISSIPATION vs. CASE TEMPERATURE




### DRAIN CURRENT vs. DRAIN TO SOURCE VOLTAGE









#### FORWARD TRANSFER ADMITTANCE vs. **DRAIN CURRENT**




# DRAIN TO SOURCE ON-STATE




#### DRAIN TO SOURCE ON-STATE RESISTANCE vs. GATE TO SOURCE VOLTAGE





### GATE TO SOURCE CUTOFF VOLTAGE vs. CHANNEL TEMPERATURE





















# SINGLE AVALANCHE CURRENT vs. INDUCTIVE LOAD
