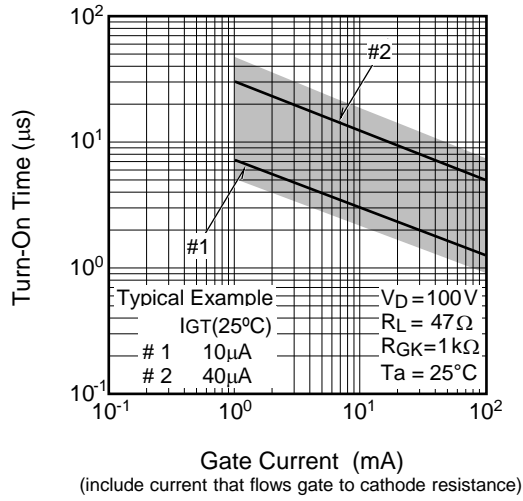
Performance Curves



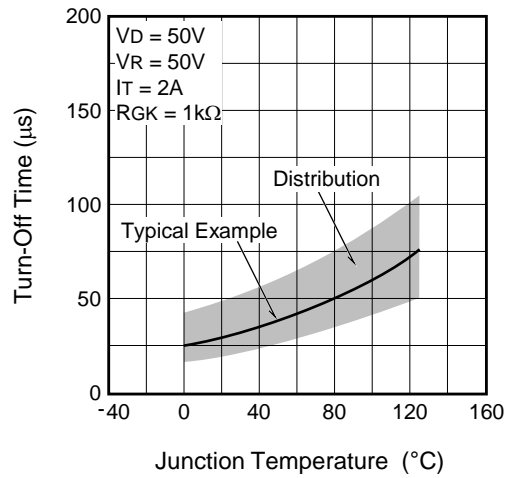




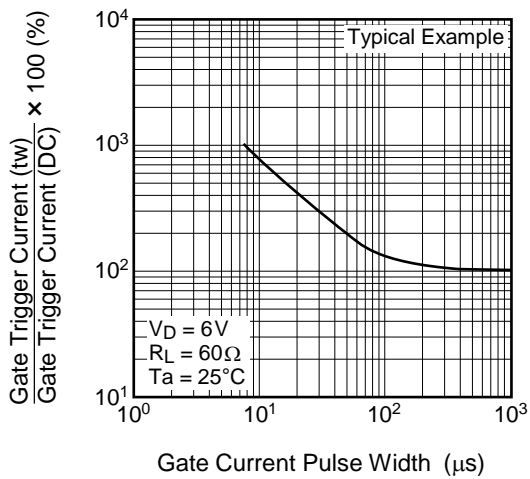
Turn-On Time vs. Gate Current



Turn-Off Time vs. Junction Temperature

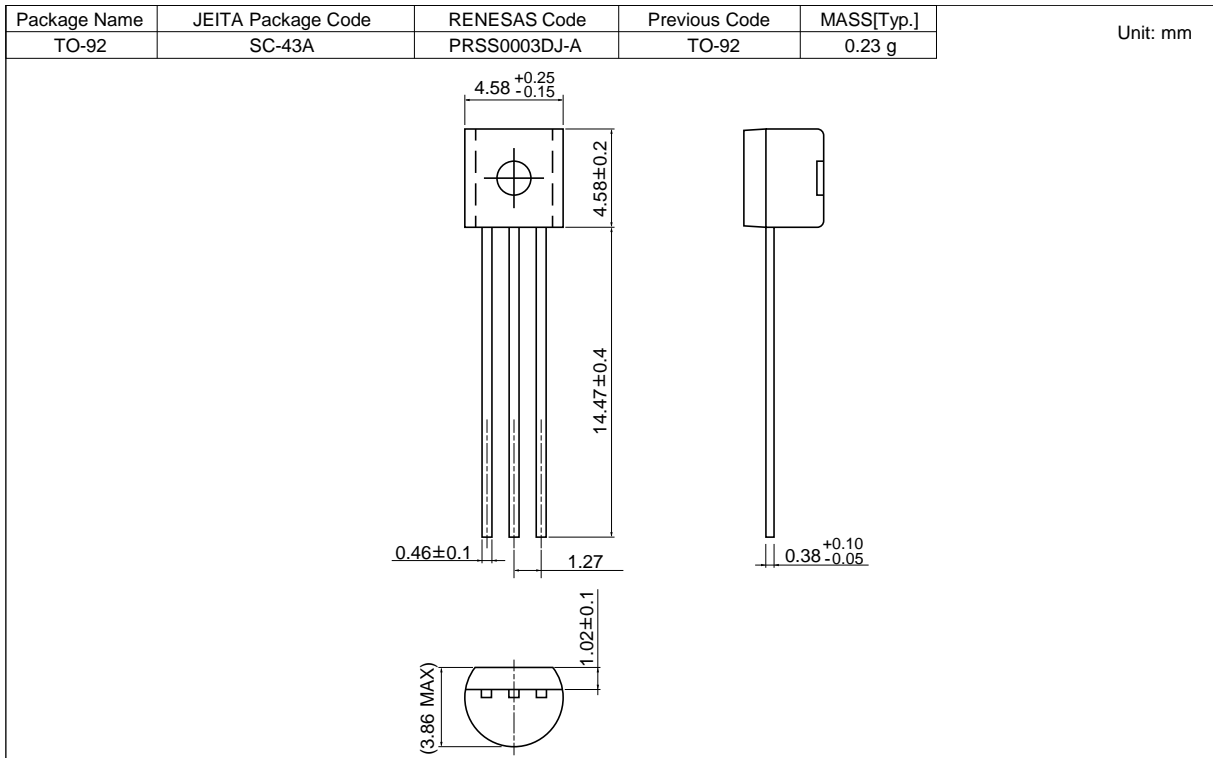


Gate Trigger Current vs. Gate Current Pulse Width

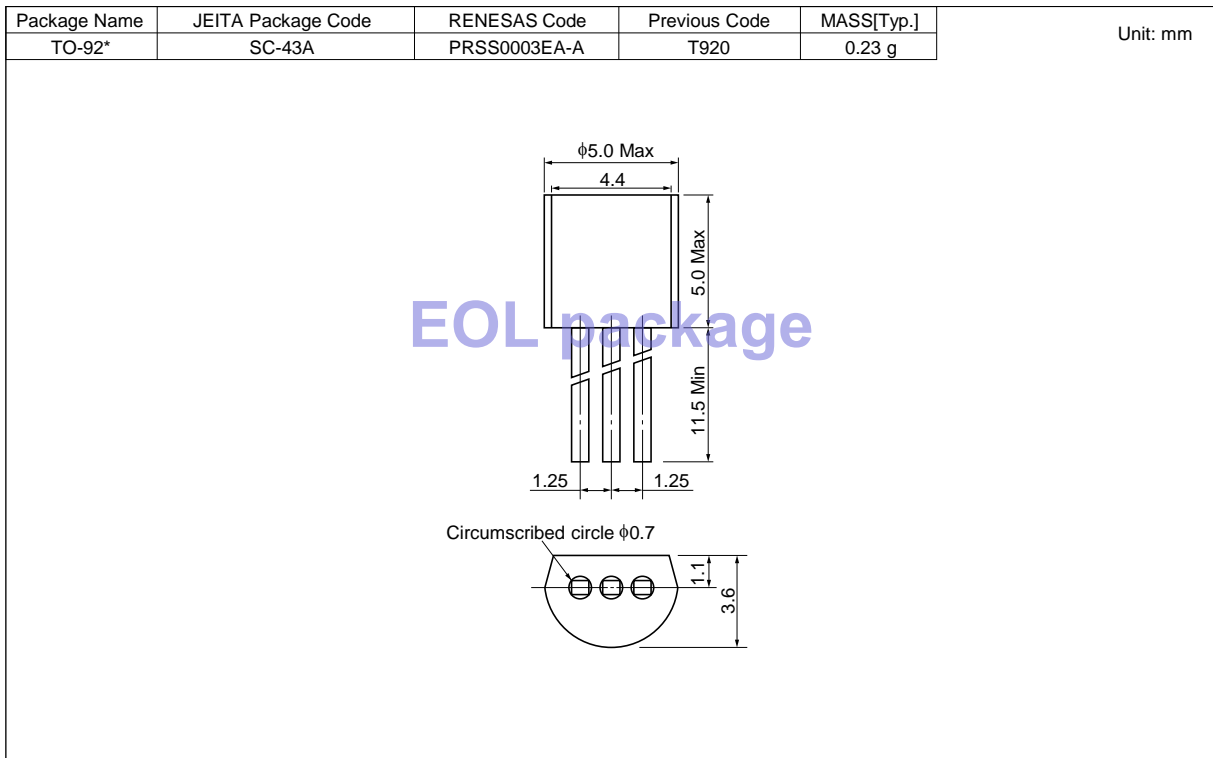
